===== Handling and Storage =====

===== Exposure Controls/Personal Protection =====

Respiratory Protection:IF EXPOSURES EXCEED ESTABLISHED LIMITS, A NIOSH/MSHA APPROVED RESPIRATOR FOR ASBESTOS SHOULD BE USED. CONSULT YOUR SAFETY OFFICE/INDUSTRIAL HYGIENIST PERSONNEL FOR GUIDANCE FOR THE TASK AT HAND.

Ventilation:LOCAL EXHAUST IS RECOMMENDED IN SITUATIONS WHERE DUST IS GENERATED BY ABRASIVE ACTIONS, ABRASION OR OTHER MEANS.
